All mortalities from Cooke taken to Kirkwall shorebase, then transferred to Dounby (near Kirkwall) for bulk uplift to Shetland.

FLS treatment carried out at the end of April 2025.

Farm management area is not fallowed synchronously as it includes both Cooke and Scottish Sea Farm sites.

During the site inspection the fish were observed shoaling deep in the water column. No dead fish or moribunds were seen across the whole site. The fish sampled for the VMD appeared healthy both internally and externally, with no sea lice attached.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

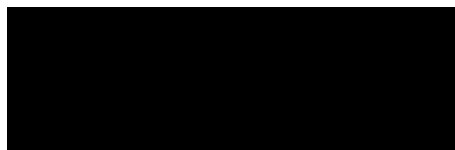
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
