Additional Case Information:

Fish input onto site in Nov 2024 from Girlsta Hatchery, with last stocking date occurring on 21/11/2024. The last crop were transferred off site in week 23 2024. In the next ~4 weeks, wrasse will be input to site; wild caught ballan wrasse from Orkney.

The site has recently undergone a full grid/equipment change (planning permission granted in 2021). Site now has 12 pens at 120m. Seal pro nets are being used as well.

Slice treatment cleared on 13/05/2025; fish are no longer in withdrawal.

2024: wk 15, 1.01%, 1538; wk16, 1.99%, 3006; Wk17, 1.76%, 2376; wk18, 1.60%, 1815; wk19, 1.16%, 1297; wk20, 1.19%, 1036; wk21, 1.43%, 624; 1.80%, 235 (all CMS related)

The FMA has ceased at the start of this production cycle, and replaced with a FMS as businesses within the management area do not fallow synchronously.

Paperwork except for movement & transport records inspected remotely on 24/06/2025. Some slight discrepancies in the reported sea lice figures were observed during the remote paperwork inspection. A request was made to resubmit these to match the figures held by the business and an issue was raised. Issue was resolved on 29/07/2025 following receipt of records which were found to be adequate.

During site visit, only 2 moribund/dead fish were observed. Fish were seen shoaling and feeding well. Site was conducting lice/gill checks and observed fish were in good condition, with few shortened opercula. Fish sampled for VMD appeared in good condition and healthy, internally and externally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be adequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had been reported to the Fish Health Inspectorate as required.

Reports detailing the results of animal health surveillance carried out by or on behalf of the business and/or Marine Directorate were available for inspection.

The biosecurity measures plan for the site was inspected and found to be adequately maintained and implemented.
