Additional Case Information:

Mortality, Sealice, Treatment record and Sea lice strategy and FMS were inspected remotely on 02/07/2025. BMP, movement records (including waste transfer records) and health surveillance records were inspected remotely on 03/07/2025.

Whilst inspecting sealice records it was noted that in the previous cycle sealice counts were over the threshold and had been reported to the the FHI accurately. In the current cycle sealice counts have been below the threshold.

At the time of inspection sea lice counts were observed. Sea counts are reflective of what has been reported and were found to be satisfactory.

Fish were observed on site and via feed cameras, they were shoaling and swimming well deep in the water column. The fish had a good feed and stimuli response. Some fish were observed to have lesions but were healing well, Site stated that the lesions were attributed to physical damage. 1 moribund fish with fin damage was removed at time of inspection. 3 moribund fish were observed across site. No gross pathology was observed so no samples were collected. It was observed that there were a high number of jellyfish (Species - comb and gooseberry jellyfish) across site.

6 fish were sampled for VMD and were observed to be in good condition externally and internally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

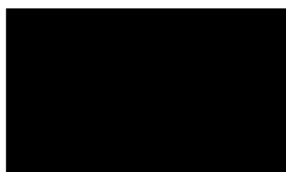
