Additional Case Information:

Wrasse are wild caught and are sourced locally to Shetland. Wrasse were inputted on 07/07/2025. There has been no wrasse mortality since input.

During the previous cycle there were elevated wrasse mortalities - 2023 wk50 967 4.99%, wk51 1001 5.43%. 2024 wk01 782 4.49%,- loss due FW treatments wk05 1677 (10.85%) - end of the cycle culls. Following loss of wrasse during FW treatments in previous cycle, site conducted risk assessments and had improvement actions to ensure wrasse are removed from the pen being treated by catching them into creels and transfer them to different pens that are not being treated.

At the time of inspection a wrasse transfer was being undertaken. The wrasse were observed to be in good condition and recovered quickly following transfer into the pens.

At the time of inspection sea lice counts were observed. Sea counts are reflective of what has been reported and were found to be satisfactory.

Fish were observed on site and via feed cameras, they were shoaling and swimming well deep in the water column. The fish had a good feed and stimuli response. 1 mortality was observed at the time of inspection. An average of 3 runts were observed per pen. It was observed that there were a high number of jellyfish (Species - comb and gooseberry jellyfish) across site.

4 fish were sampled for VMD and were observed to be in good condition externally and internally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

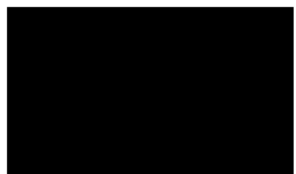
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
