Additional Case Information:

Wrasse are wild caught and are sourced locally to Shetland. Site was stocked with wrasse on 27/06/2025. Wrasse mortalities since input - wk26 0.02% (1), wk27 0.01% (1)

Fish were observed on site and via feed cameras, they were shoaling and swimming well deep in the water column. The fish had a good feed and stimuli response. 2 wrasse mortalities and 2 salmon mortalities were observed at the time of inspection. 2 fish with spinal deformity were observed across site. It was observed that there were a high number of jellyfish (Species - comb and gooseberry jellyfish) across site.

5 fish were sampled for VMD and were observed to be in good condition externally and internally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and found to be inadequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be adequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had been reported to the Fish Health Inspectorate as required.

Reports detailing the results of animal health surveillance carried out by or on behalf of the business and/or Marine Directorate were available for inspection.

The biosecurity measures plan for the site was inspected and found to be adequately maintained and implemented.



The following points were raised with the site representative during the inspection:

- The APB was not authorised to stock Wrasse at this site. An amendment authorisation application was requested to be submitted. Amendment authorisation application was received from the business contact on 07/07/2025. The outcome of the application will be issued separately. No further action required.
- Site FS numbers had been missing from the movement records. Site was reminded to input information correctly into the movement records. No further action required.

Medicine records were inspected and found to be adequately maintained.

Samples were taken to be analysed for veterinary residues.

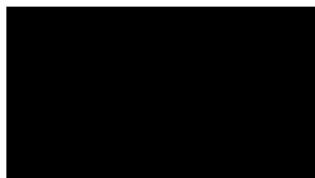
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
