Additional Case Information:

A remote inspection was conducted on 30/10/2025 – FMS, mortality, treatment, biosecurity, health surveillance and sea lice records were inspected. The remaining mortality and sea lice records up to 05/11/2025 and the movement records were inspected during the site inspection.

Risk assessment inspected for CoGP management area not falling synchronously on a single year class basis.

An ensiler at SSF Ltd mortality yard in Twatt is available but not routinely used as a method of waste disposal.

The current stock test positive for AGD (08/10/2025 third party report, 11/11 positive for AGD) and a hydrogen peroxide tarp treatment was initiated in week 42 with fish reported to have responded well to treatment. Some poor performers/runts were noted on input and were suspected of being failed smolts. The fish were vaccinated for IPN but a pooled sample of poor performers/runts tested positive (08/10/2025 third party report). Individual samples of the general population were taken and tested negative (03/11/2025 third party report, 8/8 negative for IPN).

The site is expected to be spilt down in January 2026 to Puldrite (FS0813) and fish will be transferred in freshwater.

Generally the stock on site appeared healthy and shoaling well. Two lethargic fish were observed across the site and both had a good startle response. Fish sampled for VMD appeared healthy externally and internally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.


