**Additional Case Information:**

Risk assessment inspected for CoGP management area not following synchronously on a single year class basis.

The current stock was transferred in August 2025 from Fara West (FS1017) in freshwater with FLS treatment giving high sea lice clearance. Sea lice numbers have since began to increase and freshwater with FLS treatment commenced in week 40. Treatment of the remaining 3 pens is due to be completed by tomorrow (07/11/2025).

Generally the stock on site appeared healthy and shoaling well. Approximately three to five lethargic fish were observed in each pen but all had a good startle response. Two exhibited physical damaged, attributed to the recent FLS treatment, but seemed to be healing. Sea lice levels observed on stocks reflected the sea lice count data. Some settlement damage around the caudal fin area of the fish sampled for VMD was noted but otherwise it appeared healthy externally and internally.

## Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

### Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.


