Additional Case Information:

Mortality: No reported mortality events since 13/03/2023 (5 weekly, 4.05% due to PD). Wk 35 2025 (25th-31st August): 21% (only 21 fish). At the time of this mortality, this was the last batch of fish before the current stock. East Tarbert Bay had transferred all fish on site in pen 1 (27,120) to Druimyeon Bay (FS0336), starting on the 23/08/2025. After all transfers were completed, when lifting the pen net on the 25th August, 21 dead fish were discovered at the bottom of the pen. The previous manager put this mortality down in week 35 despite the site being fallow. After reviewing the fish numbers, movement records off site and the circumstances surrounding that mortality record, it was decided that the mortality percentage for that week should be calculated against the number of fish transferred off site in the previous days. East Tarbert Bay therefore had a mortality percentage of 0.077% for week 35, 2025.

Morts ensiled and then sold for biofuel. Billy Bowie picks up and takes to Dundas.

Treatments: FW/FLS 25/10/2025 - for sealice. Alphamax/FLS: 07/09/2025 and 27/09/2025 - prescription seen, all cages treated due to sealice.

Health surveillance: Vets 23/09/2025 - Aquatic vets visit 9 days after fish transfer onto site. No issues found, signs of early maturation. Company biology team 15/09/2025 - Low PGD scores, signs of early maturation. Patogen report 10/10/25 - 19/20 positive Aeromonas salmonicida, 12/21 positive piscine orthoreovirus, negative for moritella viscosa, SAV, PDV, Pasteurella skyensis O2, Pasteurella atlantica + skyensis O1, 14/21 positive for PMCV and 7/20 positive for Yersinia.

Sealice: Sealice numbers have been low during period checked except since week 38 2025. Druimyeon Bay treated for sealice week 38 (3.6, mainly caligus) - it is theorised that during crowding the lice shed their eggs which went with the tide down to East Tarbert bay, giving rise to the increase in lice numbers. Normally treatments would be synchronous for both sites however the treatment boat was required elsewhere urgently therefore East Tarbert bay was not treated at the same time. Treatments at East Tarbert Bay have reduced lice numbers. Last weeks figure is 0.45.

The site is currently being used as a grower site with and no full cycles have been carried out since 2021 due to mass mortality events at the time.

During physical inspection of the site only one dead fish was seen across the whole site. One exothalamic fish was observed in one pen and each of the six stocked pens had between 1-5 fish with dark colouration. In all pens the majority of fish were shoaling deeper in the water column. Of fish observed at the water surface, no lice were seen. One pen was being fed at the time of inspection and fish had a good feed response.

One fish was taken from pen 2 for VMD sampling. This fish appeared healthy internally and externally. The fish had 2 sealice on it at the time of sampling.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be inadequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had been reported to the Fish Health Inspectorate as required.

Reports detailing the results of animal health surveillance carried out by or on behalf of the business and/or Marine Directorate were available for inspection.

The biosecurity measures plan for the site was inspected and found to be adequately maintained and implemented.

The following points were raised with the site representative during the inspection:

- Week 35, 2025 mortality of 21 fish had been recorded incorrectly as 21%.
Correct mortality calculated as 0.078% after discussion with site manager and review of records. No further action required.

Medicine records were inspected and found to be adequately maintained.

Samples were taken to be analysed for veterinary residues.
