Site inspected on 08/12/2025; all fish seen were observed to be feeding well and looked healthy. Culled fish were inspected and found to be in excellent health.

3 tanks - 0 sea winters; 6 tanks - 1 sea winter; 3 tanks - 2 sea winters (1 tank culled as of 08/12/2025).

Waste transfer records seen for the interim use of transporter whilst the incinerator is broken and found to be satisfactory.

As a broodstock site, it does not fallow synchronously on a single year class basis. This is noted in FMS inspected. No harvesting takes place on site.

In addition, harvesting strategy is not required as site has land based tanks and is able to treat easily.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:


