Site thermometer used due to biosecurity restrictions, site thermometers are regularly calibrated against a glass thermometer

Site has been fallow since August 2025. Site is currently being restocked with fish from the Parr Unit (FS1336).

Furunculosis was an issue last cycle, histo, bacteriology and PCR confirming this.

Site was subject to an extensive clean down and fallow period due to the furunculosis, entire system has been cleaned including the biomedica pipework etc.

Peaks in mortality 2025 wk 21 7075 (12.26%), wk 22 24946 (4.92%), wk 23 16334 (1.80%), wk 24 160150 (10.09%), wk 25 522145 (36.58%), wk 26 117735 (13.01%), wk 27 10120 (1.29%), furunculosis

Recent mortalities, wk 4 898 (0.11%), site is currently being restocked no additional data.

Treatments administered since June 2025 are Florocol for Furunculosis and one formalin treatment.

Some fungus noted but not significant.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.


Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
