Some tanks on ambient the RAS tanks are on heated water. Site thermometer used due to biosecurity. Site temperature probes are calibrated against a UKAS accredited digital lab thermometer that is recalibrated on a regular basis.

Morts last four weeks, wk 4 7101 (0.92%), wk 3 5163 (0.66%), wk 2 1801 (0.23%) wk 1 1108 (0.14%) fungus and handling to split tanks down.

Fungus the main fish health issue with the site, cold temperatures has exacerbated the issue. Treatments with Aquacen and Cress. Some tanks have been vaccinated, Micro 6 and Clynav.

Some fish with fungus were observed in several tanks.

## Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

### Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.


