Issues with airlock in the pipework, this has been an ongoing problem. Various fixes have been tried but the entire system is to be replaced with a view to be finished by Summer. A fix had been put in place that was considered to have rectified the issue but an airlock occurred in January resulting in a loss of 22311 alevins.

Ova input end of November 2025.

Mortalities last four weeks, wk 4 (1900 (0.52%), wk 3 22311 (5.75%) air lock, wk 2 2083 (0.53%), wk 1 6009 (1.52%) post hatch.

Site thermometer used due to biosecurity, site thermometers are regularly calibrated against a UKAS accredited digital lab thermometer that is verified for 6 months.

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.


