Additional Case Information:

On 21/01/2026 samples were collected and processed by the companies biologist and 24% of fish sampled tested positive for Piscirickettsia. There is some AGD. During the inspection of the site fish were observed shoaling well and responding positively to routine feeding regimes, fish were also observed from the cameras during feeding where the population appeared in healthy condition. No clinical signs of disease were observed during the site inspection and mortality on the site is currently low. Scadabay completed a round of freshwater treatments + FLS earlier in the month and the fish have responded well to the treatment.

The site began its current production cycle in September 2025 and mortality has been low, with no weeks recording over the reporting threshold for mortality. Between April - June 2022 during the sites last production cycle, the site experienced significant gill health challenges which caused high levels of mortality which was reported to the FHI.

The site treated with Slice in October 2025, Freshwater in November 2025 and a further freshwater treatment in January 2026 following identification of some AGD in the stocks.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.


Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
