Site stocked 16/01/2026. Buffodine disinfection carried out upon arrival.

Ova sourced from Ardessie (FS1372) and are at the alevin stage. All stock appeared in good health with low mortalities so far. 2025 stock had increased mortalities but did not go above reporting levels. Wk 7 - 5.97% (116114), wk 8 - 4.53% (82860), wk 9 - 0.99% (17345). These were determined to be egg quality issues with other sites experienced same issues with ova from same source.

Site thermometer used for biosecurity reasons. Site thermometers are internally calibrated annually with these records available.

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.


