Additional Case Information:

Mortality starting to increase due to a delay in getting the fish to sea caused by bad weather. Although on the rise, the mortality level is still below the notifiable criteria. Mortality mostly attributed to HSS.

Water very peaty (which is reportedly normal for this loch) so visibility was poor making it difficult to observe the fish. Seven fish across the site were observed with small white lesions that resembled saprolegnia on the head or dorsal fin. These fish were not moribund and appeared otherwise healthy.

All fish sampled for VMD displayed no signs of disease externally or internally and food was present in the gut.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.
