Additional Case Information:

Freshwater treatments were last carried out on 24/01/2026. The site has been conducting approximately one freshwater treatment per month since July. Thermolicer treatments have also been conducted for sea lice control, along with three rounds of Slice and four rounds of Salmosan.

An antibiotic treatment was administered between 12–18 October using Florocol. This treatment was required due to *Pasteurella*, which the fish responded well to.

The most recent fish health report was dated 03/01/2026. CMS is currently the main driver of mortality on site; however, mortalities remain low. Cleaner fish mortality recorded over the previous four weeks was 194 fish.

The site is actively harvesting and is scheduled to be followed by the end of March 2026. Only three pens remain stocked.

During the inspection of the site a seal was found inside Pen 5. The net was lowered, allowing the seal to exit the pen. It is suspected that the seal entered by passing over the handrail, and the site does not believe any fish escaped. An initial escape notification was submitted by the site manager on the date of inspection. On 05/03/2026 a ROV was deployed into pen 5 to check for any damage to the nets and confirmed that no holes or damage was present. The site are confident that no escape of fish has taken place.

Fish on site appeared to be in good health at the time of inspection. No clinical signs of disease were observed. Two fish were removed and sampled for VMD testing; both fish were found to be healthy internally and externally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

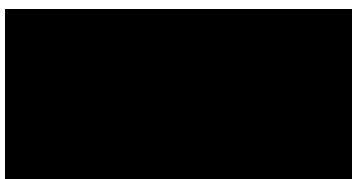
