**Additional Case Information:**

Mortalities: Weeks 27, 32, 33 in 2025 all low figures (200-400) due to harvest.

Treatments: SLICE (2-8th January). Last cycle - 3 SLICE treatments and one freshwater treatments. Plans to stock cleaner fish once the pens are split down later in cycle (just wrasse).

Non-synchronous following risk assessment seen.

Health surveillance: Only gill swabbing so far this cycle (30/01/2026) - 1/8 positive for AGD. Most recent 17/02/2026 - 0/4 for AGD.

Remote inspection of paperwork carried out 20/02/2026. Additional paperwork and physical inspection carried out 24/02/2026. During physical inspection of the site fish were shoaling deeper in the water column. Only 6 moribund fish observed across the whole site. VMD samples taken from pens 2 and 5 - all fish appeared healthy externally and internally and only one *L.salmonis* observed.

## Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

### Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be adequately maintained.


## **Inspection under the Aquaculture and Fisheries (Scotland) Act 2007**
