Additional Case Information:

Weather was changeable during inspection, with southerly winds creating motion through the site. Visibility was mixed at time of inspection, stock showed good feed response. One lethargic fish observed on site, near the centre of pen so unable to catch. Fish sampled for VMD appeared to be in very good condition.

6 pens currently stocked and these will be split across the remaining 4 pens. Site is having some issues with seal predation, they have reportedly been trying different things such as running aeration and moving the depth and location of the aerators, this was reported to work for a few days and then seal predation losses would increase.

Nets usually weighted with 20kg per stanchion, but these have been doubled to 40kg per stanchion to increase the tensioning of the net, this was not reported to have prevented losses. It was hoped that splitting the stock to the remaining 4 pens, reducing biomass in each pen across site, will help alleviate the losses being caused by seal predation.

In the last production cycle there were a number of SW to SW movements, risk assessments were available for inspection for these.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

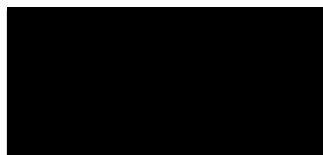
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
