Additional Case Information:

Intakes from Inchmore on 11th January over 4 days. Mortality has been low since input and previous crops have also experienced very low mortalities, however, following an increasing trend in fungus at the hatchery, the site were advised by their health team to perform weekly bath treatments of formalin and cress to reduce the risk of an outbreak.

Fish on site appeared in good health, with the exception of a handful of individuals who were displaying clinical signs of fungal infection. These individuals were not moribund and could not be caught with a hand net. The fish removed and sampled for VMD were in good physical condition, had a good layer of fat surrounding the PC and their guts had food present.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

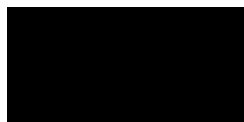
