Mortality and Treatment records were inspected remotely on the 27/02/2026. Movement, containment, biosecurity measures plan records and stock details were inspected on the day of inspection 03/03/2026.

Site have observed an increase in deformities in this batch compared to previous years. Stock came from Aquagen.

Stock was moved from the comp hatches to tanks week beginning 23/02/2026. Wk9 observed an increase in mortalities this was attributed to the transfer and start of first feed. Site have observed that most mortalities are deformities.

The stock were observed to be shoaling and swimming well. Stock were observed to have a good feed response. Approximately 10-12 morts were observed per tank. The morts were also observed to be deformities.

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records
