Last potential escape reported 2010. No more events reported since last visit

Central disposal of waste-Stored at Badcall before being sent for biowaste to Grey in Banff AB452XS

Slice treatment 5th to 12th Feb 2026. Last cycle FW, thermolicer, FLS and salmosan treatments.

Dead haul to Dingwall for harvest.

Movement book not available during visit as it is kept at Badcall. Was offered to visit the office but was not passing that way. Sent through electronically post inspection. Movement book therefore not signed. Movement records received 30/3/26. BMP and farm management statement received ahead of visit 11/3/26.

No health surveillance this cycle other than on site gill health check and lice counts. Previous cycle - no major issues.

Current fish input from 5/12/25 from Ormsary - to date very low lice figures ranging from 0 to 0.1 adult female average.

Last input was bus stop delivery with fish going to Laxford then on to Loch Carnan.

On site inspection no significant issues were observed in the pens.

## Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

### Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.


## **Inspection under the Aquaculture and Fisheries (Scotland) Act 2007**
