Additional Case Information:

Freshwater treatment used in Feb 2026 once gill scores began to rise. Gill condition has reportedly improved significantly since the treatment. Treatment did not affect lice numbers as they were close to zero adult females per fish.

Withdrawal period for TMS set at 21 days as the fish are destined for the US market. In the US 21 days is set at standard quarantine period for salmon set by FDA.

TMS used to sedate fish up to 3kg, after that point Optomease will be used.

About 2 fish observed across the site with lesions consistent with infection with *Moritella viscosa* (aka winter sores). These fish were not moribund.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:
