Mortality peak Week 4, 2025: 2.69% (31,325) - due to a power cut on site. Fish were 0.3g and below the reporting mortality threshold.

Treatments: Formalin 2/3/2026 in the smolt unit. Cress 26/02/2026.

Most recent health surveillance report 16/02/2026 - No significant results.

Site thermometer used for biosecurity reasons.

During physical inspection, only one dead fish was observed across the whole site. Fish taken for VMD sampling appeared healthy both internally and externally.

Fish taken for VMD sampling were in withdrawal for tricane, formalin and cress.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.
