Treatments: Hydrolicer, thermolicer and FLS treatments over the years.

Last health surveillance: 4/03/2026 - some fish with winter sores, some CGD.

Remote inspection of paperwork carried out on 13/03/2026. Physical inspection and remaining paperwork carried out 18/03/2026.

During the physical inspection, adverse weather conditions prevented safely securing the work boat to the pens. Due to this only 4 pens were accessed and inspected by the pen walkway. The other 8 pens were inspected from the workboat going alongside each pen. Most fish were shoaling deep in the water column with a handful observed leaping out of the water. No moribunds were observed on site.

One fish from pen 11 was taken for VMD sampling. This fish appeared healthy externally and internally, with 3 sealice on the body.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be inadequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had not been reported to the Fish Health Inspectorate. I would like to remind you of the R25

industry agreement in relation to mortality reporting as detailed in A Code of Good Practice for Scottish Finfish Aquaculture.

Reports detailing the results of animal health surveillance carried out by or on behalf of the business and/or Marine Directorate were available for inspection.

The biosecurity measures plan for the site was inspected and found to be adequately maintained and implemented.

The following points were raised with the site representative during the inspection:

- Mortality event Wk 41, 2025 of 1.06% (3996 fish) had not been reported to the FHI. This has been reported to the FHI retrospectively. No further action required.

Inspection under the Animals and Animal Products (Examination for Residues and Maximum Residue Limits) (England and Scotland) Regulations 2015

Medicine records were inspected and found to be adequately maintained.

Samples were taken to be analysed for veterinary residues.


Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
