Pens 3, 5, 13 and 14 are in withdrawal for T.M.S

Last company health report (10/03/2026) had no significant findings - some fish with winter sores, some CGD.

Remote inspection carried out 13/03/2026. Remaining paperwork and physical inspection carried out 18/03/2026.

Physical inspection took place in adverse weather conditions. Each pen was inspected from the walkway but due to tidal conditions a full walk round each pen was not possible.

During the physical inspection, only one moribund was observed across the whole site and it had a small lesion on its flank. Most fish were deep in the water column but a handful were seen leaping out of the water. No lice were observed.

One fish was removed from pen 12 for VMD sampling. This fish appeared healthy externally and internally.

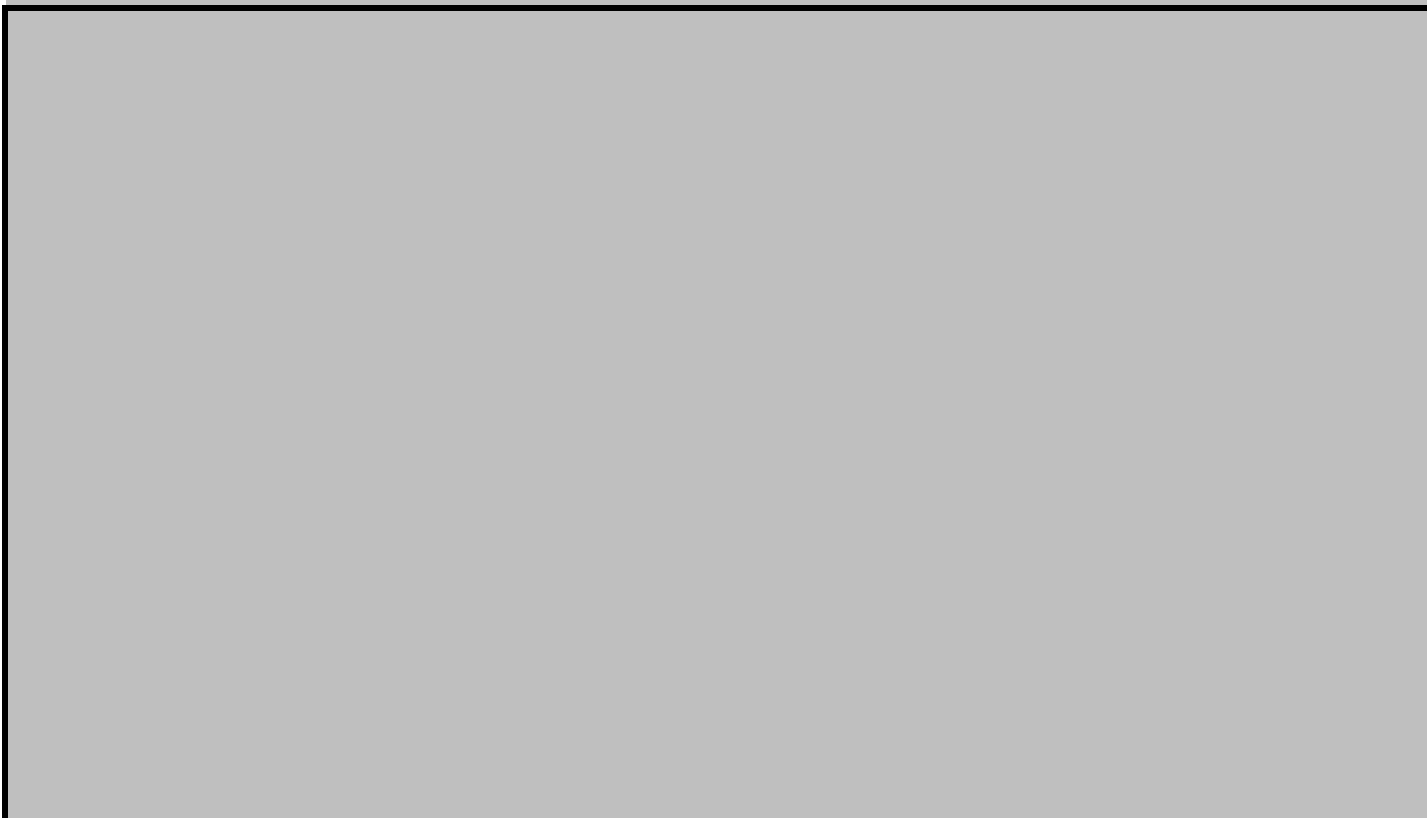

## Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

### Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.
