Additional Case Information:

Site inspection could not be conducted due to adverse weather conditions. Movement, mortality, treatment, health screening, SLI records were inspected along with the FMS and biosecurity measures plan while at the shore base.

Only treatment carried out since last inspection has been freshwater FLS treatments. TMS was used week prior to inspection on 3 pens for grading purposes. Stock on site is organic.

Broodstock held on site so sea lice inspections are carried out visually from the walkway weekly. As no physical count is being conducted, there is no way of knowing if the average adult female lice count has been above the CoGP suggested criteria for treatment or above the intervention level during the period that records have been inspected. Freshwater treatments have been carried out during this period so based on that, lice loads are more likely to have been above CoGP suggested criteria for treatment on occasion.

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

Records


