The site is split into two areas ongrowing 1 and ongrowing 2, mort records are split between the two so mortality records are kept separate, data was combined post inspection to determine mortality levels across the site.

Peaks in mortality 2024, wk 23 26359 (1.02%), wk 24 28457 (1.12%), wk 25 26859 (1.07%), wk 34 31895 (2.16%), wk 35 27932 (1.18%), wk 36 32848 (1.42%), wk 37 (58407 (2.60)), wk 38 (32329 (1.49%)), wk 39 25834 (1.24%), wk 40 21573 (1.05%) fungus the main cause.

Peaks in mortality 2025, wk 46 15086 (1%) fungus.

Peaks in mortality 2026, wk 8 28717 (1.10%) fungus.

Treatments for fungus in 2024 included bronopol and formalin. Due to the impacts of treatments on the biotower no treatments have been administered since October 2024.

Fish appeared in good health.

Site thermometer used due to biosecurity measures.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected, in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Medicine records were inspected and found to be adequately maintained.


Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
