Additional Case Information:

Paperwork done remotely on 30/03/2026, movement record checked, site inspection and VMD sampling on 07/04/2026. Seal Pro HDPE nets, Froyer Rings, centre weights on some pens to combat seal interaction. Vaccination against furunculosis, ERM, PD. AGD swabs & gill scores every 2nd week currently but may be more frequent if issues arise. SLICE to combat Caligus numbers and H2O2 for AGD.

Normally use TMS for sea lice counting but nearer harvest have the option of using Optomease for a shorter withdrawal period. Top nets are stitched to the production net to prevent seal ingress. Options to use SLICE, Salmosan, H2O2, FW & FLS, AMX & Deltamethrin for sea lice management along with physical removal. No issues reported on site. Can have jellyfish and algal bloom issues depending on environmental conditions but monitor to detect any potential issue early.

Two WRS mortalities removed during visit and one moribund fish with signs of physical damage due to predator interaction. One moribund fish observed which was opened by site health staff who considered the fish demonstrated signs of Moritella infection (ascites and choc-chip liver). No samples taken as site health staff had used a contaminated knife and gloves to examine the fish prior to any possible sampling. 6 fish sampled for VMD demonstrating no clinical or post mortem signs of disease.

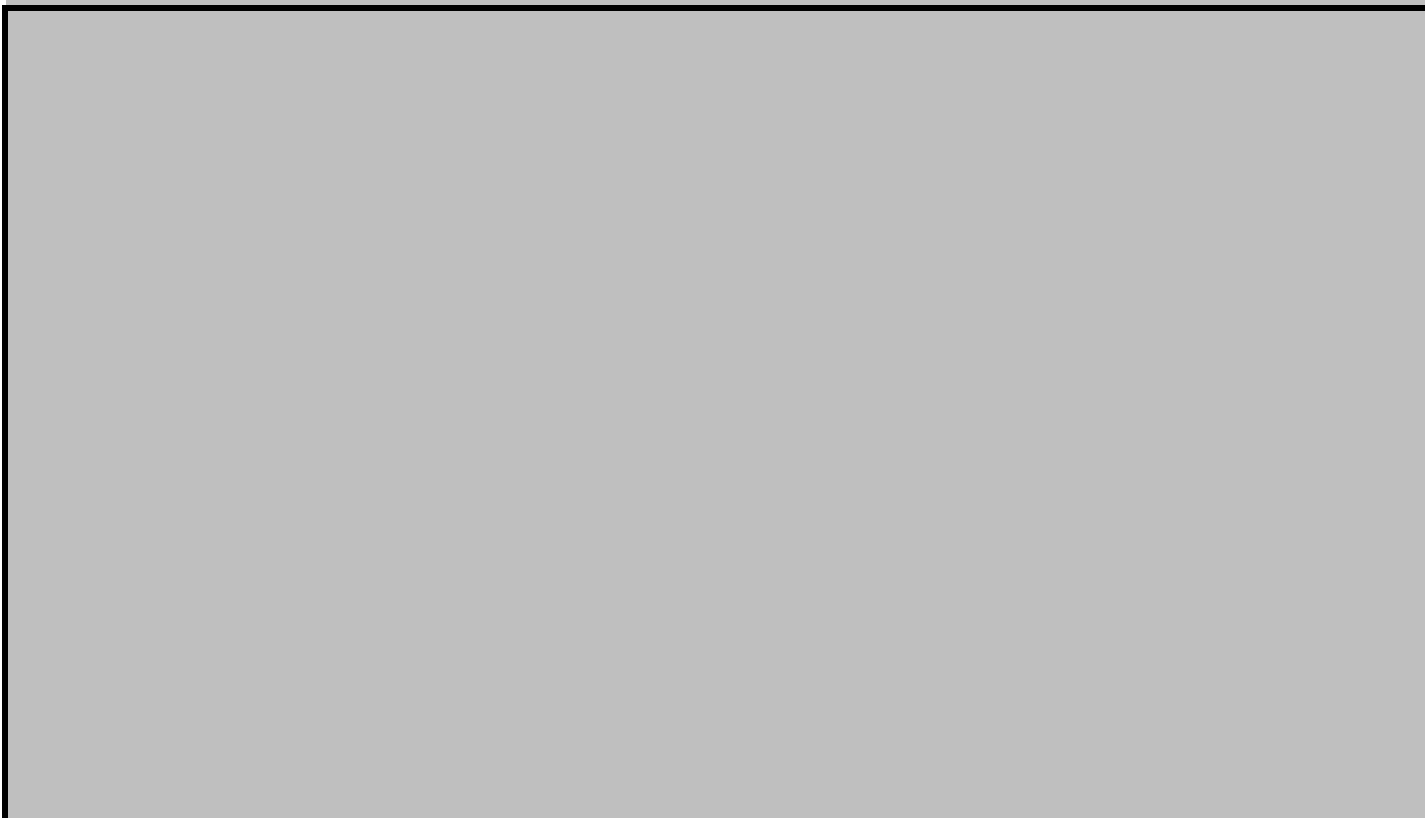

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:
