Additional Case Information:

Fish came on from Loch Etive in Feb 26 and have had low mortality since input. Health of the fish has been good, with low PGD/AGD scores and good body condition noted. A grade was completed last week and the fish are expected to remain on site until the end of the year when a portion will be deadhaul harvested, and the remaining stock will be moved to another SW site for ongrowing until harvest.

Site has not had any escapes since the last reported escape incident in October 2025. The move to sealpro nets and the removal of the tidal barrier are two of the improvement measures that were implemented following the escape. The site manager has reported that although seals are still observed around the site, damage to equipment and stock has significantly reduced.

The only medicinal treatment that has been conducted on site since input (with the exception of anaesthetic for sealice counts) was SLICE in March 26.

The general population of fish on site were in good physical condition and were active in the cages. There were several individuals with physical damage observed in each of the cages, with around 20 individuals with damage observed in cage 1. This had been caused by the handling event the week before. No clinical signs of disease were observed and fish were still relatively active so no diagnostic samples were taken on this occasion. Fish sampled for VMD was in good condition externally and internally.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:
