No fish treatments are used for fish, but fish are vaccinated against ERM by their supplier. When ponds/tanks are emptied, they are treated with lime and/or copper sulphate to protect fish against eye flukes.

Some damage to nets and some mortalities are attributed to predation (namely otters and mink). Any damage to equipment and netting is repaired and maintenance log is kept as a record of these repairs.

Site is struggling to keep up with demand for fish from the restocking industry (put and take fisheries).

VMD fish appeared healthy when sampled.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.
