Additional Case Information:

The Farm Management Area (FMA) is not fallowed synchronously; however, a risk assessment is in place. As a mitigation measure to reduce the risk of sea lice transfer between the APB and the other operator within the FMA, the APB makes its Thermolicer available to the neighbouring operator prior to any introductions of salmon smolts.

The risk assessment for seawater-to-seawater (SW-SW) transfers was inspected and found to be satisfactory.

4 moribund fish were observed, including 1 moribund fish with a high sea lice burden. 7 fish with spinal deformities were noted; however, all were swimming well. Fish had been displaying elevated levels of jumping activity prior to the scheduled feed, which reduced significantly following feeding. Visibility was limited, and most fish appeared to be holding deeper in the water column. The fish that were observed were in good condition, swimming well, and showed a strong response to stimuli. Feed response was excellent.

Wrasse were observed to be in good condition, swimming actively and exhibiting a strong feeding response. Overall, their appearance and behaviour were consistent with good health and welfare.

Net washing operations were taking place at the time of inspection.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.

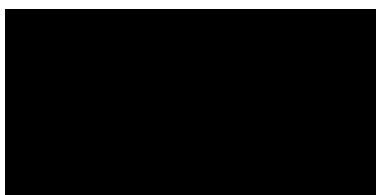
