Additional Case Information:

The Farm Management Area (FMA) is not fallowed synchronously; however, a risk assessment is in place. As a mitigation measure to reduce the risk of sea lice transfer between the APB and the other operator within the FMA, the APB makes its Thermolicer available to the neighbouring operator prior to any introductions of salmon smolts.

Recent wrasse mortality has been attributed primarily to furunculosis and transport-related losses. However, mortality rates have improved over the past few weeks, indicating that the situation is stabilising.

The risk assessment for seawater-to-seawater (SW-SW) transfers was inspected and found to be satisfactory.

2 runt fish were observed, along with 1 fish exhibiting exophthalmia. 1 fish with a spinal deformity was also noted; however, all affected fish were swimming well. Fish displayed elevated levels of jumping activity prior to the scheduled feed, which reduced significantly following feeding. Visibility was limited, and most fish appeared to be holding deeper in the water column. Fish observed during the inspection, including those viewed on camera, were in good condition, shoaling and swimming well, and showed a strong response to stimuli. Feed response was excellent. 1 mortality was observed and was removed at the time of inspection.

Wrasse were observed to be in good condition, swimming actively and exhibiting a strong feeding response. Overall, their behaviour and appearance were consistent with good health and welfare. 1 wrasse mortality was observed.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.

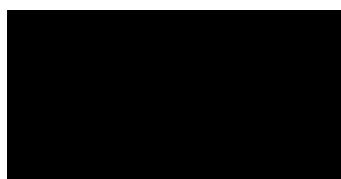
