Additional Case Information:

First stock transferred onto site from Marulaig Bay last week. One pen with large grade, one with small grade. More fish to be transferred in from Marulaig Bay and Stulaigh. Will hold approximately 1,000,000 fish one fully stocked. No cleaner fish stocked on site and no plans to hold any this cycle unless required.

Freshwater treatment administered in wellboat during transfer. Seal nets being fitted to pens. Use foover to remove mortalities daily, will use divers if required. Will start harvest in October.

A few fish observed with scale loss, but fish appeared healthy.

Mortality, treatment, sea lice, VHP/biosecurity and FMS checked remotely 29/5/2026. Remainder of paperwork checked during inspection.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

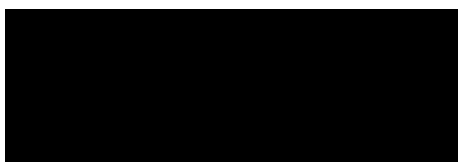
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
