Additional Case Information:

Site stocked October 2025 from Loch Lochy. No cleaner fish currently on site and no plans to stock this cycle unless required. Have been grading fish, with transfers to Stulaigh South and Groatay. Fish will also be transferred to An Camus. Harvesting will start late August 2026

Mortalities have been low since input, main causes have been transfer losses from freshwater to seawater, runts/poor performers and freshwater treatment losses. Use foover to remove mortalities daily.

Several treatments carried out on site since input for AGD and/or lice. Hydrogen peroxide in December 2025 for AGD, Slice in February 2026 and freshwater in January, February, April and May 2026 (January and May treatments combined with FLS).

Due to availability of boats and staff, site was inspected on 2/6/2026 (all pens except 8 & 14) and 3/06/2026 (pens 8 & 14). Mortality, treatment, sea lice, VHP/biosecurity and FMS checked remotely 29/5/2026. Remainder of paperwork was completed on 3/6/2026.

Some scale loss observed on fish most recently graded and a couple seen with physical damage on flank. Fish sampled for VMD appeared healthy.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and appeared to be adequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained.

Mortality records were inspected and found to be adequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had not been reported to the Fish Health Inspectorate. I would like to remind you of the R25

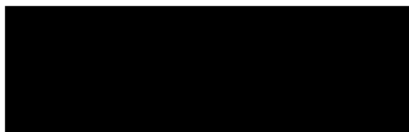
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
