Additional Case Information:

3 dead observed across site, not fresh dead and two lethargic fish observed deeper in the water. Visibility at time of inspection was excellent, population demonstrated good shoaling behaviour and good feed response.

A large quantity of crab larvae observed in pens, site rep reported that this wasn't a common occurrence. Not reported to causing any issues with stock on site.

1 fish sampled for VMD appeared healthy and in very good condition, no sea lice observed on fish and sea lice numbers have been low.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:
