Additional Case Information:

1 fish removed for VMD, appeared healthy and in very good condition with no sea lice observed. Sea lice numbers are low across site. A few thousand crab larvae observed in cages across site.

Site name to be updated from Grey Horse Channel Outer to Greanem.

Site has pole top nets and these were reported to work well on site, top nets are stitched to pen nets.

Greanem is a high energy site, with exposure from easterly winds. Fish planned for Greanem are grown to ~2Kg at Groatay and Grey Horse Channel before being split down. Excellent visibility at time of inspection, fish observed shoaling well. 3 fish observed across site displaying signs consistent with predation damage.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

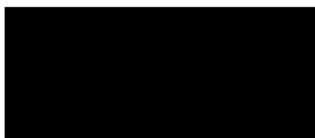
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
