Peaks in mortality 2025: wk 14 8440 (1.10%) water quality/failed smolt , wk 15 20146 (3.28 %) most of these were from SFNOV 23 batch 16905, recorded as water quality issue (high free ammonia levels), wk 16 12885 (2.51%) water quality and failed smolt (high free ammonia levels), wk 17 14442 (4.44%) failed smolt and diagnosis pending , wk 19 3853 (1.79%) diagnosis pending, wk 41 34791 (2.57%) failed smolt, wk 49 62669 (3.96%) smolt transfer to marine, wk 52 12505 (1.33%) smolt transfer to marine.

Peaks in mortality 2026: wk 7 7119 (1.60%) smolt transfer to marine, wk 10 17844 (4.93%) smolt transfer to marine, wk 11 3553 (1.55%) failed smolt, wk 15 4064 (1.81%), wk 18 5973 (1.37%), wk 19 4960 (1.15%) fw transfer/physical damage following grading, wk 21 6215 (1.47%) smolt transfer to marine.

Mortalities for last four weeks 18, 19 and 21 listed above wk 20 623 (0.15%), wk 22 126 (0.06%).

Smolt transfer to marine are post transfer morts recorded at the sea site.

Morts in early 2025, lab reports showed saprolegnia, mixed bacterial infection, nephrocalcinosis.

One RAS unit is fallow the other is in operation.

Slice is the only treatment administered in the unit, this is done prior to putting fish to sea.

Site thermometer used due to biosecurity protocols.

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as high. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.

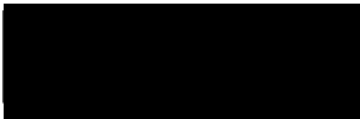
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
