Wrasse peaks in mortality, wk 42 815 (1.92%), wk 45 1091 (2.84%), wk 46 1329 (3.56%) all recorded as wounds/fin damage. wk 49 874 (3.12%), wk 51 1096 (4.09%) all recorded as atypical furunculosis

Wrasse peaks in mortality 2026 wk 2 2059 (8.05%) atypical furunculosis

Lumpfish mortalities were recorded in early 2025 but not elevated.

Peaks in salmon mortality 2025: wk 44 9110 (1.7%) gill health bacterial infection, wk 45 15650 (2.97%), wk 46 6970 (1.75%) mainly gill health but some well boat FW treatment losses, wk 48 7169 (2.16%), wk 49 4795 (2.04%), wk 50 5981 (2.09%) Gill health, wk 51 3365 (1.16%) Gill health, HSMI and some pasteurella.

Peaks in salmon mortality 2026: wk 1 750 (1.21%), wk 2 971 (1.58%) gill health..

A treatment with SLICE administered in April, FW wellboat/FLS was used in late May early June 2025 and also November 2025. Alphamax was used in July and August.

Mortalities last four weeks: Wk 23 (to date of inspection) 96 (0.01%) Wk 22 441 (0.02%), wk 21 358 (0.02%), wk 20 142 (0.01%), wk 19 192 (0.01%). No cleaner fish on site.

Some sea water to sea water transfers from Cairidh and Tabhaigh (risk assessment in place).

Due to algal bloom at the time of the inspection feeding was restricted.

Very low levels of lice, zero observed on the fish sampled for VMD.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as high. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and found to be inadequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be inadequately maintained.

Mortality records were inspected and found to be adequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had been reported to the Fish Health Inspectorate as required.

The biosecurity measures plan for the site was inspected and found to be adequately maintained and implemented.

The following points were raised with the site representative during the inspection:

- Wrasse movement records were not maintained in the required format therefore some information was not recorded. These records have since been updated therefore no further action is required.

Medicine records were inspected and found to be adequately maintained.

Samples were taken to be analysed for veterinary residues.

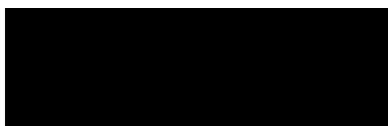
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
