Additional Case Information:

Site inspected in overcast conditions with a calm sea state, visibility of the stocks was good. Fish were observed shoaling well and responding positively to routine feeding. The site is currently fully stocked, with 12 70m pens. Only 1 moribund fish with a lesion to the flank was observed during the inspection. 2 Fish were removed for VMD sampling and both appeared healthy internally and externally.

No cleaner fish on site currently, the site does plan to stock some wild caught wrasse later in the production cycle.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

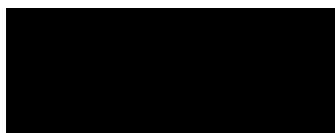
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
