Additional Case Information:

REG carried out in March due to bad weather. All documents were inspected at the time. Documents will be inspected from March.

Health surveillance - 17/06/26 - 4/7 fish tested positive for piscine myocarditis virus (PMCV) and 6/7 fish tested positive for aeromonas salmonicida (frunculosis). All fish tested negative for piscirickettsia and yersinia ruckeri.

Fish are currently being treated with antibiotics for frunculosis (started on 17th for 10 days), prescription seen while on site.

Additional treatments - Freshwater treatments 1st May and 16th June.

Frunculosis started in the last couple of weeks leading to elevated mortalities (small number of fish but due to low numbers on site, higher mortality). This week due to the antibiotic treatment starting, the fish are looking much better with lower mortalities. Not seeing many moribund fish this week.

Broodstock are held on site so sea lice inspections are carried out visually from the walkway weekly. As no physical count is being conducted, there is no way of knowing if the average adult female lice count has been above the CoGP suggested criteria for treatment or above the intervention level during the period that records have been inspected. Freshwater treatments have been carried out so there is a possibility that lice loads have been above CoGP suggested criteria for treatment on occasion.

Physical inspection of the site - A small number (10-15) fish in pens 1 and 2 were observed with skin lesions to the head or flank. No lesions were observed on fish in pen 6. No moribund fish were observed on site. Fish in pen 6 were observed feeding and had a good feed response. No lice were observed from the pen walkway.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:
