Additional Case Information:

Pen 3 from Knock (FS0254), rest of pens are from Barcaldine Smolt Unit (FS1354). Wrasse are all wild-caught from Uig. Split down to Dunstaffnage planned for Wk30.

Site is co-ordinating with Mowi in Loch Linnhe - synchronised fallow period.

Wrasse mortality for June 2026 - total mortality count in period is 44. Initial input was 6024 (split only into 2 pens).

Historical mortalities: 2025 Wk11, 1.26%, 3163; Wk13, 1.27%, 3119; Wk14, 1.92%, 4466; Wk15, 1.50%, 3416; Wk22, 1.45%, 1186; Wk23, 1.49%, 1197; Wk24, 1.82%, 1263; Wk26, 5.00%, 194 (all mortalities attributed to complex gill disease, HSMI and CMS).

Only treatments/medicines used on site this cycle: Syncline and Tricaine Pharmaq - both T.M.S.

One fish sampled from pen 1 for VMD sampling. This fish was observed to be in good health.

During the site inspection, all pens were examined. Fish throughout the site were observed to be actively jumping, which was considered to be associated with the low-salinity freshwater layer and the significant amount of debris present within it. Although Caligus levels were slightly elevated, they were not considered to be the primary factor contributing to the observed behaviour.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as medium. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every second year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

Aquaculture animal and aquaculture animal product movement records were inspected and found to be inadequately maintained.

Records in relation to aquaculture animals transported by the business were inspected and found to be adequately maintained

Mortality records were inspected and found to be adequately maintained.

Mortality levels had exceeded the reporting criteria since the last inspection and had been reported to the Fish Health Inspectorate as required.

The biosecurity measures plan for the site was inspected and found to be adequately maintained and implemented.

The following points were raised with the site representative during the inspection:

- Waste Transfer notes do not detail location/name of disposal site. In future, should site be using a third-party waste contractor, waste transfer notes should be checked to ensure they are completed accurately and note disposal site. Confirmed on the invoice that waste taken to Barkip Biogas. No further action required.

Samples were taken to be analysed for veterinary residues.

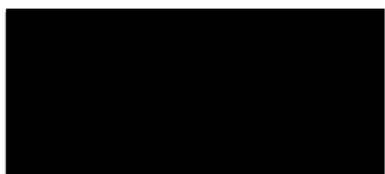
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
