Additional Case Information:

FW treatment occurred 06/07/2026. Second Slice treatment began 07/07/2026 - all pens being treated.

Historical Wrasse mortalities: 2025, Wk45, 774, 3.60%; Wk46, 682, 3.29%; Wk47, 831, 4.14%, Wk48, 1171, 6.09% (all handling related).

No wrasse on site yet, but plan later in the cycle. Wrasse may be being brought on from NI in future.

During the site inspection, it was noted that an issue with the hydraulics on the wellboat had caused an amount of fish to spill onto the deck of the vessel on the 06/07/2026 to 07/07/2026. An initial notification for an increased risk of escape was submitted to the FHI on 07/07/2026. To note, under the CNI section of this case, the site staff were unaware of whether the DFSB and the SSPO had been notified and therefore noted as N. While site containment was observed to be satisfactory on the day of inspection, further review is required to determine whether containment procedures were followed appropriately by site personnel and third-party contractors, and whether any recommendations are necessary.

Live haul will be conducted on most occasions but deadhaul may occur.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as high. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted annually. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

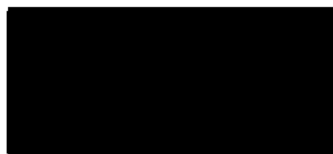
