Additional Case Information:

Last Florocol treatment administered in 2025 (30/09 - 01/10/2025). Last FW treatment - 09 to 15/06/2026. Post FW treatment fish tested positive for HSML and SRS, but mortality remained below the threshold. Due to the size of the fish and potential for SRS to become more significant because of rising water temps, it was decided to harvest the site to fallow. Last harvest planned for 14th July.

No wrasse or lumpfish on site - no plans to stock cleanerfish in next production cycles

Rum acts as a grower site and usually gets transfers from Etive.

3 fish were removed and sampled for VMD. All fish were observed to be in good condition and healthy.

Inspection under the Aquatic Animal Health (Scotland) Regulations 2009

The above site was inspected in accordance with the Aquatic Animal Health (Scotland) Regulations 2009.

All epidemiological units were inspected. On this occasion no samples were taken for disease analysis. The Inspector did not observe any clinical signs associated with the listed diseases as described in the Aquatic Animal Health (Scotland) Regulations 2009.

Records

The surveillance frequency category of the site was assessed as low. An inspection under the Aquatic Animal Health (Scotland) Regulations 2009 will be conducted every third year. The category of the site will be reassessed on a routine basis and updated as required.

The information required for the public record of aquaculture production businesses regarding this site was verified and where necessary updated. The following records were also inspected to ensure that the conditions of authorisation for your Aquaculture Production Business (APB) are being met:

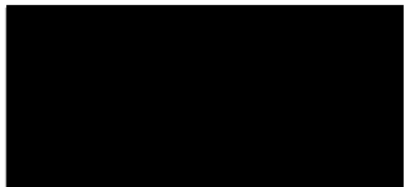
Inspection under the Aquaculture and Fisheries (Scotland) Act 2007
