Additional Case Information:

The site was inspected following reports of elevated mortality from the company and third party communication. The visit was conducted alongside APHA who carried out a welfare inspection.

Stock transferred in spring 2025 from Ormsary Smolt Unit (FS0575) and Duartmore (FS0770). The site has reported high mortalities in weeks 26 and 27 due to gill health. A freshwater treatment was carried out in week 24. The site has reported low DO events in the evening due to the rising temperatures, this is being rectified with the installation of an O2 barge to supplement oxygenation on the site as required. Wild wrasse were stocked in week 25. Sea lice figures have doubled in the last week, climbing to 3.96 adult females/fish in week 29.

During the visit, every pen was inspected and visibility was very clear. The main population appeared in good condition and exhibited a very strong feeding response. A small number of lethargic fish could be observed in the pens, however these would quickly swim away when approached. These fish were mostly runts, and a small number of spinal deformities. The lice load on these appeared high although no grazing damage could be observed. The lice load in the general population was moderate. A small proportion of fish in the general population had signs of lesions in the caudal region, however these had been observed to have healed. A higher number of fish also had dorsal fin lesions, these appeared to have been healed for a long time.

One moribund was found at the time of inspection. The fish was removed from the pen for further analysis. The salmon presented bilateral eye exophthalmia. The fish was a runt and there was no feed presence in the stomach or gut but otherwise no other internal changes were noted. Partial mortality for week 29: 52 (0.01%).

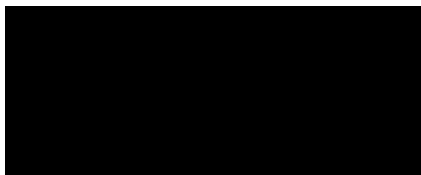
