NOTES & REMINDERS:

- Multiple exhibitors from the same address may be listed on one order form.
- Please check 4-H, FFA or Other and list the department entered (beef, sheep, share the fun, etc.).
- Our exhibitor parking lots are available to those with entries on file for the current year; otherwise, Lot A (north lot) parking will be issued.
- Vehicle permit(s) will be issued for the date(s) indicated on the form. Lots will be determined as forms are received. If dates are not indicated on the form, a Lot A vehicle permit (good for any one day) will be issued.
- Return ticket order form to the Iowa State Fair at the address listed below. **DO NOT** return ticket order form to the county extension office or chapter advisor.
- Ticket order form is due July 20. After July 20 tickets and vehicle permits may be purchased at the Entry Department (located on the State Fairgrounds in the Administration Building). Tickets and vehicle permits will not be mailed if order form is postmarked after July 20.
- There is no charge for admission or vehicle permits on the days prior to the Fair, August 2 - 6. If a pre-Fair vehicle permit is needed, please indicate above. Vehicles without a permit will not be allowed on the grounds. A livestock unload pass will allow vehicle on the grounds to unload.
