## IOWA STATE FAIR CONTEST GIVEAWAY HAIRBALL GIVEAWAY RULES

**ELIGIBILITY:** The HAIRBALL giveaway promotion is open to legal residents of the United States, who are eighteen (18) years of age or older at the time of entry.
