IOWA STATE FAIR BRETT YOUNG GIVEAWAY

GIVEAWAY RULES

ELIGIBILITY: The lowa State Fair BRETT YOUNG GIVEAWAY is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry. Eligible jurisdictions may enter the lowa State Fair BRETT YOUNG GIVEAWAY.
