## **IOWA STATE FAIR MÖTLEY CRÜE GIVEAWAY**

## **GIVEAWAY RULES**

ELIGIBILITY: The Iowa State Fair MÖTLEY CRÜE GIVEAWAY is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry. Eligible jurisdictions may enter the Iowa State Fair MÖTLEY CRÜE GIVEAWAY.
