Reminder: An admission ticket or a wristband is required for admittance onto the Fairgrounds. There will be no exceptions. Admission tickets and wristbands can be purchased on Open Class entry forms, Discount Ticket Order Forms (available online, through your County Extension Office or through your FFA advisor) or by contacting the Entry Department at 515-262-3111 ext. 242.

There will be a \$20 charge for each returned check and issuer could be liable for up to three times the amount of the check. Cash, Cashier's Check or Money Order will be required if a check is returned for insufficient funds. No refunds of \$10 or less will be issued.
