1) **24-hour Hotline/Individual Advocacy/Legal Advocacy - We provide short-term crisis intervention, safety planning, information, referral, support and advocacy as requested by people affected by domestic abuse and violence. Information about protection from abuse and harassment orders is offered on the hotline and at our resource centers. Court accompaniment and limited representation is also available. We provide information and referrals for representation regarding family law, including parental rights and responsibilities, and information about criminal processes. In Fiscal Year 2017, 1,835 individuals were served with a total of 8,197 contacts.**

2) **Emergency Shelter - We provide shelter for victims of abuse, including children. Shelter workers are available to help residents apply for benefits, find childcare and housing, and search for other services such as healthcare and counseling. Parenting and budgeting assistance is available. Household items, personal items, toys and food are provided to residents. In Fiscal Year 2017, 67 individuals were served for a total of 3,330 bed nights.**

3) **Prevention and Community Education - We provide training, education and systems advocacy in many venues and all sectors of the community including schools & other youth-based programs, employers, healthcare, childcare, faith communities, the legal system, child protective services, social service providers and many more. In Fiscal Year 2017, community education and training was provided to 1,170 individuals, and school and youth-based activities were provided to 3,116 youth.**
